- 10.All the allottees have to join in the Residents' Welfare Association and Corpus fund of Rs.50/- per Sft. shall be paid at the time of registration of flat to TGRSCL.

12. Payment Schedule:

- i. After completion of the lottery, "Intimation letter" will be issued to the successful applicant to pay the 25% (1st installment) of the Flat cost within 7 days, from the date of issue of Intimation letter. If not paid within stipulated time, EMD will be forfeited.

- iii. Balance cost of the flat within 60 days from the date of allotment.
- A. "No-Objection Certificate" (NOC) will be issued for obtaining Loans from Banks / financial institutions subject to sanction by the respective Banks and forward the registered sale deed directly to the Bank.
- B. **Forfeiture of Token Advance:** If the successful allottee fails to pay 25% of the total flat cost within the stipulated time/ not willing to take the flat allotted in the lottery, the token advance paid by him / her will be forfeited.
- C. Lottery will be conducted flat wise & tower wise and category-wise in a transparent manner from applicants who have submitted the token advance.
- D. The DDs of the successful allottees will be retained and DDs of the un-successful allottees will be returned on the same day after completion of the lottery for all the categories. In case an applicant who has paid token advance/EMD is unsuccessful in the lottery for a flat of his choice, then he/she can participate in lottery for another flat of a similar/lower category of flat with the same EMD amount.
- 13.Flats will be registered to the allottee or his / her nominee(family member) on fulfilling the 100% payment and other conditions. Third parties will NOT be entertained.
- 14. Managing Director, TGRSCL, reserves the right to differ, cancel, alter and modify the process of allotment.
