ORDER:

In the reference first read above, the Collector, Ranga Reddy District, has reported that, on the requisition filed by M.D., A.P. Rajiv Swagruha Corporation Ltd., he has proposed for alienation of land to an extent of Ac.148.07 gts., in certain villages of Quthubullapur (M) in favour of A.P. Rajiv Swagruha Ltd. He has also reported that according to the village records the Sy.No.268, 270, 278 of Nizampatnam village is classified as Sarkari and Sy.No.79, 346, 354, 170 in Galularamaram Village is classified as Government land and Sy.No.170 of Mallapet village is classified as Gairan Sarkari and Sy.No.39 & 40 of Bachupally is classified as Government land. He has further reported that he has requested to allot the land to an extent of Ac.148.07 gts., in certain villages of Quthubullapur (M) in favour of A.P. Rajiv Swagruha Ltd.

2. In the reference second read above, the Chief Commissioner of Land Administration, Hyderabad has reported that the Empowered committee has recommended the proposal for alienation on payment of values as per G.O.Ms.No.1440, Revenue (Asn.V) Department, dt.04.12.2008.

3. After careful examination of the matter, Government hereby direct that the following Government lands to an extent of Ac. 117.11 gts., in certain villages of Quthubullapur (M) be alienated in favour of A.P. Rajiv Swagruha Corporation Ltd on payment of Mid value at column No.6, subject to conditions 6 of Andhra Pradesh (Telangana Area) Alienation of State Land Revenue Rules, 1975 and other usual conditions.
