In the reference first read above, the Collector, Ranga Reddy District, has reported that on requisition filed by M.D., A.P. Rajiv Swagruha Corporation Ltd., he has proposed for alienation of land to an extent of Ac.18.30 gts in Sy.No.46 of Kurmalguda (V), Saroornagar (M). According to the village records Sy.No.46 of Kurmalguda is classified as Sarkari. The basic value of the land in vicinity is Rs.35.00 lakks per acre and the market value is Rs.70.00 lakks per acre.
