ORDER:

In the reference first read above, the Collector Ranga Reddy District, has reported that, on the requisition filed by M.D., A.P. Rajiv Swagruha Corporation Ltd., he has proposed for alienation of land to an extent of Ac.100.00 in Sy.No.383 of Torrur (V), Hayatnagar (M). According to the village record in Sy.No.197 of Nadargul is classified as Sarkari Gairan. He has also furnished the market value in the vicinity of proposed land is Rs.15 to 75 lakhs per acre. He has requested to allot the land to an extent of Acs.83.00 gts in Sy.No.197 at Nadargul (V), Saroornagar (M) in favour of A.P.Rajiv Swagruha Ltd.

2. In the reference second read above, the Chief Commissioner of Land Administration, Hyderabad has reported that the Empowered committee has recommended for alienation in favour of Rajiv Swagruha Corporation on payment of Mid value @Rs. 45.00 lakhs per acre as per G.O.Ms.No. 1440, Rev(AsnV) Dept, dt.04.12.2008.

3. After careful examination of the matter, Government hereby direct that the Government land to an extent of Ac.100.00 in Sy.No.383 of Torrur (V), Hayatnagar (M) be alienated in favour of A.P.Rajiv Swagruha Corporation Ltd., on payment of Mid value @ Rs.45.00 lakhs per care, as per G.O.Ms.No.1440, Revenue (Asn.V) Department, dt.04-12-2008, subject to conditions under Rule 6 of Andhra Pradesh (Telangana Area) Alienation of State Land Revenue Rules, 1975 and other usual conditions.
